

## CONTRACT FOR THE SALE OF A DOMESTIC PET DOG

### CONDITIONS OF SALE

1. The Buyer agrees to maintain the dog in good condition, including adherence to a regular immunisation schedule, heartworm preventative, good diet, worming & grooming routines, and a clean and safe loving environment.
2. The Buyer understands this dog is sold to them on the Limited Register only. The Buyer acknowledges they have read the information on the Limited Register & signed the Limited Register Agreement before signing this contract.
3. All Siberians are sterilised before they leave us, you acknowledge that the Siberian Husky you are purchasing is a pet only and cannot be used for breeding.
4. The Buyer shall provide a collar and identification tag for the dog to wear at all times so that the dog can be properly identified.
5. As Siberians love to run, please keep your new dog on leash or in fully fenced area at all times. You are putting your new family member at risk by not adhering to this advice, therefore it may be considered to be neglect on the part of the Buyer.
6. The dog shall reside at the Buyer's address. You acknowledge that you are not purchasing a Siberian Husky for a friend, family member or third party.
7. If the dog cannot be kept by the Buyer, the Buyer shall notify the Roguehusky Siberians immediately. The dog shall not be sold, transferred, or given to any individual or to any retail or wholesale establishment for the purpose of sale or resale to the public. First offer is to be made to Roguehusky Siberians at no cost, so that we can find another suitable family for the dog.
8. The Buyer agrees that it is their responsibility to accept the dog as described to them by Roguehusky Siberians. We have provided to the best of our knowledge & in good faith that we have sold you a happy healthy husky. Roguehusky is not liable for any veterinary costs of the dog once it has been paid for & taken into the care of the Buyer.
9. The Buyer agrees that Roguehusky Siberians is in no way liable or responsible for any damage, accident, or injury resulting from the dog.
10. We strongly encourage the Buyer to attend some form of dog training for socialization and teaching for their new Siberian husky. It is recommended that your new Siberian be involved in some form of training until at least 12 months of age.
11. The Buyer agrees to keep Roguehusky Siberians informed of their current addresses.
12. Should the Buyer be unable or unwilling to fulfill any of the above provisions, the Buyer agrees to return the dog to the Breeder at the Breeder's request. Should the Buyer refuse to return the dog, the Buyer hereby authorises the Breeder to pick up and remove the dog from the Buyer's control.

**BUYER:** The UNDERSIGNED Buyer hereby acknowledges having read the terms of the Contract and does hereby agree to abide by each of the provisions set forth above.
